Authors need to follow the following guidelines while contributing papers for bulletin:

1. Title should be in **bold, Calibri** with font size **14**.
2. The write up should be in **Calibri** with font size **11**.
3. Author(s) names, designation, institutes, emails should be noted clearly.
4. Abstracts should not be crossed 300 words and mention 3 to 5 Keywords
5. Papers should be completed within 4,000 to 5,000 words.
6. Papers will start with an abstract and keywords followed by introduction, research methodology, analysis, discussion, conclusion and references. Photographs and table of the result part and graphs as well as charts also should be used to support the write up.

• **For table(s):**

Please submit tables as editable text and not as images. Tables can be placed either next to the relevant text in the article, or on separate page(s) at the end with annexure. Number of tables consecutively in accordance with their appearance in the text and place any table notes below the body of the table.

• **For Figure(s) and Chart(s):**

Ensure that each illustration has a caption. Supply captions separately, not attached to the figure. A caption should comprise a brief title (not on the figure itself) and a description of the

illustration. Keep text in the illustrations themselves to a minimum but explain all symbols and abbreviations used.

- **Citation in text:**

Please ensure that every reference cited in the text is also present in the reference list (and vice versa).

7. Local words will be in italics with English translation in bracket.
8. The article will be accepted after plagiarism checking.
9. Full responsibility shall be with the authors regarding the each and every content of the paper as well as opinion of the authors or any controversial issues in research. However, neither the publication company nor the editorial board shall be responsible in this regard.
10. For reference follow the APA 7th edition format.
